**CATERING BUTCHERS AND GAME HANDLING ESTABLISHMENTS  
REQUIRING APPROVAL UNDER REGULATION 853/2004**

In October 2006 the FSA wrote to you (ENF/W/06/045) setting out its intention in Wales in respect of catering butchers and game handling establishments which you had identified as likely to require approval by the Agency under Regulation 853/2004. The premises remain under local authority control until approved or conditionally approved by the Agency.

The exercise to carry out assessment visits to all those catering butchers and game handling establishments in Wales by the Agency's Veterinary Meat Hygiene Adviser is now drawing to a close. Annex A attached lists all the premises identified by you to date and confirms their status by local authority area.
